St. Louis, Aug. 26, 2009 – The Work Number<sup>®</sup> announced today that verification of employment (VOE), verification of income (VOI), and IRS Form 4506-T requests for tax transcripts and employer W-2s can be simultaneously fulfilled through its employer-direct and government-direct services, allowing lenders to get verified income from a single provider and meet the underwriting guidelines recently updated by the Government-Sponsored Enterprises (GSEs).

Recently published guidelines by Fannie Mae, which take effect September 1, state that the requirement of IRS Form 4506-T and pre-closing VOE for all borrower types on any Fannie Mae sponsored loan has been increased. Lenders who use The Work Number service can meet the new standards by requesting a pre-closing employment verification from The Work Number within 10-days of the note date.
